INTRODUCTION

Police officers are appointed to assist and protect the communities in which they serve. In doing this, police focus primarily on performance measures that are law-enforcement agency-oriented (Sparrow, 2015). Metrics that focus solely on agency goals may fail to consider the human costs involved in achieving these goals, specifically within Black communities.

CURRENT PROBLEM

- Members of Black communities are three times more likely to die during officer-civilian encounters than those in White communities (Fatal Police Shootings Database, 2015-2022).
- Police performance metrics based on an outdated policing model may be partly to blame (Fielding & Innes, 2006; Sparrow, 2015).
- This issue is being revisited although experts have insisted upon police performance measurement revision for decades (Ali et al., 2020; Fielding & Innes, 2006).
- Agency-based metrics = crime reduction, clearance rates, response times
- Community-based metrics = legitimacy, racial representativeness, procedural justice
- Research suggests replacing agency-based metrics with community-based metrics that align with the values and needs of community members and influence public support for the police will improve outcomes (Ali, 2020; Hong, 2016; Sparrow, 2015).

FORENSIC IMPLICATIONS

> The employment of evidence-based social justice research in the context of police performance can lead to interventions that address legal system inequities and inform actions for improvement in police-community relationships, specifically within Black communities.

► Replacing outdated law enforcement metrics with empirically sound community-based metrics can strengthen police-community relations and give a voice to the

populations police are sworn to serve.

>Improved relations will likely reduce the amount of policecivilian violence and potentially lead to an increase in trust in the U.S. legal system.

POLICY RECOMMENDATIONS

>Per the Refund the Police Act of 2022 and President Biden's State of the Union address this year, law enforcement agencies nationwide are looking to be refunded. We recommend a percentage of this refunding be allocated to social justice research endeavors, specifically in the area of police reform. > We recommend the development of a transparent, research-toaction framework detailing the process in which evidence-based research projects can develop into a more effective and sustainable police performance measurement system. We also recommend that U.S. police forces move toward greater collaborations with researchers and communities by creating open access data sharing platforms.
